Master's in Private Law

Program Overview

The Master of Private Law program with the civil and commercial law tracks is a program offered by the Faculty of Law at Yarmouk University in response to the local and Arab market's need for legal competencies specialized in private law.

Success in this program requires studying (33) credit hours distributed between compulsory requirements and elective requirements in addition to the comprehensive exam, where the student studies a common package of compulsory courses, while the student's precise specialization in civil or commercial law is determined through the optional courses that he studies from the allotted hours. For each path and through the subject of the message if he is approved for transfer to the message system if the legally specified conditions are met.

Program Objectives

The Master of Private Law program aims to:

1. Preparing jurists equipped with advanced knowledge in private law with a focus in one of its branches, commercial law or civil law.
2. Preparing jurists capable of applying this knowledge in complex cases and criticizing current legal solutions while adhering to the values of justice and the rule of law.
3. Developing skills related to analyzing legal problems at the level of private law and finding appropriate solutions within a sound legal framework.
4. Strengthening scientific research and legal studies within a sound methodological plan that reaches logical results and recommendations that are applicable in practice.

Program Importance

The Master of Private Law is considered an important program for those working in the legal field, including lawyers, consultants, judges, and researchers. It contributes to meeting society's needs for specialists in civil and commercial law. The program provides graduates with the experience, legal information, and skills necessary to practice legal work and provide consultations and research in a systematic and accurate manner.

Targeted Group and Accepted Majors

1. Holders of a bachelor's degree in law or its equivalent who wish to continue their studies in the master's program.
2. Lawyers, judges and state employees.
3. Arab students who hold a bachelor's degree in law/law or its equivalent.

Job Areas

1. Banks.
2. Companies.
3. Government departments, public institutions and courts.
4. Law, arbitration and legal consulting offices.
5. Factories and insurance offices.

Credit Hours and Tuition Fees

The study plan consists of (33) credit hours.

Credit hour fees for a Jordanian student: (70) Jordanian dinars, and (225) US dollars for an international student.

Study Plan Overview

The number of credit hours for the comprehensive Master of Law program for the thesis track is (33) credit hours, and the student can transfer to the thesis track if the legally specified conditions are met.

The credit hours are distributed as follows:

- Comprehensive track: Mandatory specialization requirements, numbering (24) credit hours, in addition to the comprehensive exam, and optional specialization requirements, numbering (9) credit hours.
- The thesis track: compulsory specialization requirements of (15) credit hours and (9) credit hours for the thesis, and optional specialization requirements of (9) credit hours.
