# Master's in Figh and its Foundations

## **Program Overview**

The Master's program in Fiqh and its Foundations affiliated with the Department of Fiqh and its Fundamentals in the Faculty of Sharia and Islamic Studies. The program aims to graduate distinguished scientific competencies from graduate students, which in turn contribute to serving the local and university community by presenting Sharia knowledge in the field of Fiqh and its Fundamentals in an authentic manner based on evidence and Sharia rules. The program aims to strengthen cooperative academic relations with corresponding departments in other universities, such as exchanging visiting professors and supervising and discussing scientific dissertations for graduate students. This, in turn, contributes to building a distinguished academic edifice in the science of jurisprudence and its principles.

## **Program Vision**

A pioneering program in graduating academic competencies specialized in Fiqh and its Fundamentals in accordance with the values of authenticity, modernity, and moderation.

### **Program Mission**

The Master of Fiqh and its Foundations program at Yarmouk University seeks to provide students with concepts and knowledge related to the texts of Sharia and its objectives, which enable them to derive Sharia rulings for emerging issues, and develop their ability for scientific research and critical thinking.

#### **Program Objectives**

The program aims to:

- 1. Knowing the various facts and information related to Figh and its Fundamentals
- 2. Familiarity with the methods of extracting the reasons for the rulings that influenced the Fiqh outcome in separating what was separated and bringing together the issues that came together.
- 3. Using the necessary knowledge and skills to link emerging issues and their Fiqh rooting.
- 4. The ability to deal with Figh issues and link them to reality.
- 5. The ability to correctly employ the correct methods of reasoning in order to reach a judgment
- 6. The ability to benefit from the fatwas of predecessors on the issue he is exposed to
- 7. It represents the principles and foundations of objectivity when deriving and applying legal rulings

### **Program Importance**

A pioneering program in graduating academic competencies specialized in Fiqh and its Fundamentals in accordance with the values of authenticity, modernity and moderation, and granting the student a Fiqh talent that qualifies him to issue fatwas and consider emerging issues according to an original comparative Fiqh vision.

**Targeted Groups and Accepted Majors** 

The program targets bachelor's degree graduates in the faculties of Sharia and Islamic

Studies. The originality of holders of a bachelor's degree in Figh and its Fundamentals is

accepted. The conditions for those holding other legal specializations are accepted.

**Job Areas** 

The graduate can work originally in university teaching, the Ministry of Education, the

Ministry of Endowments and Islamic Affairs and Holy Sanctities, and later in the civil and

military fatwa departments, the chief judge's department, family reform offices, and the

Sharia law firm.

**Credit Hours and Tuition Fees** 

The student studies in the program 33 credit hours. The one-hour fee is 70 dinars for a

Jordanian student and 225 US dollars for a foreign student.

Study Plan Overview

The plan consists of 33 credit hours, each 3 hours representing a course, distributed as

follows: 24 compulsory theoretical hours, and 9 elective hours chosen from a package of

27 hours, which the student usually studies between four and six semesters. It is followed

by a comprehensive exam in which the student is given two opportunities, in order to

achieve success, which is the condition for graduation.
